As with any pin and password, this should be kept in a safe place and retained for future reference, when contacting or accessing ESV systems.

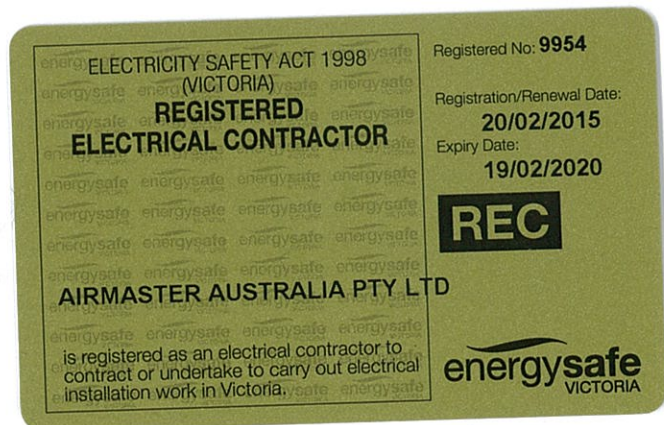
Any lost or stolen card requires a statutory declaration to be completed and a fee may be payable for a replacement card. This should also be reported immediately to ESV.

- You have access to the NSW Civil and Administrative Tribunal to resolve disputes with licensed contractors, suppliers, manufacturers and consumers.

Your statutory responsibilities as a Contractor Licence Holder are:

- All work where the reasonable market value of the combined labour and material costs exceed \$5,000 must have a written contract;
- All contracts must show the names of the contractor and the consumer and must include the licence holder's name, licence number, contract price, plans and specifications (where applicable) and relevant warranties required by the *Act 1989*. - You are not permitted to request a deposit for more than 10% of the contract price;
